COMMITTEE REPORTS

- 1. Education—Deb Bucciarelli
- The 3rd Thursday of every month "sew possible meetings": each focusing on a particular subject. Cost \$5.00/session
 Locations may vary, but each will be 10:30-3:30.
- The intent is to enhance education—not to take away from programs.
- 2. Programs—Peg

NEW BUSINESS

1. Budget

- —Information given to insurance provider was updated to accurately
 reflect the current membership numbers: 250
- Cost of insurance is \$700.00
- —Amanda questioned whether we have looked at possible meeting locations should that ever become necessary. There are facility reserve monies in the budget to aid in this.
- Dues for 2026 will remain at \$25.
- —Discussed having no reduction in fees if joining after mid year.
- —The new budget was accepted unanimously.

— All receipts should be submitted by the December meeting.

2. Charity—Laurie

- Approximately 335 quilts for Community Hospital this year
 Number of quilt donations expected to go down in subsequent years.
 Mudsock will offer batting cut to 60"x70"
- Sub-committee of Chris Behme, Becky Morello, Becky Mathison, and Sandy Metzger will handle future fabric donations
- —Finished quilts will be given to a selected charity every 2 months
 Suggested charities include: Dayspring, Cooper House, Hope Center,
 Fishers Fire Station, Hamilton County Coroner, Pediatric Diabetes
 Association, Community Hospital. Final selection will be at the discretion of the charity committee.
- —Allyn questioned how many quilts kits are out right now? Unknown.
- —Lots of discussion ensued revolving around the loss of the storage room and getting rid of it's contents. Sally felt that she had no voice in how to handle the dismantling, and Diane read a prepared statement reflecting her views. It reads as follows:

"OUR VOICE DOESN'T MATTER ANY MORE"

As the founding member of Community North Quilting Bee and

"Administrator" of said group for 8 years, I am appalled at not being included in the "Executive Board" phone conference regarding closing the storeroom.

My opinion and the opinions of the storeroom committee were not included in the discussion of how to handle the notice to vacate. We were okay to lead and work countless hours in the storeroom, host sewing days and inspiring members to quilt for Community, but we were not asked our ideas but were TOLD by the board what actions were going to happen.

Only Laurie Farthing was invited to attend the conference call and only she could vote. I think Section 1 of the Bylaws needs to be looked at. My purpose

In bringing our feelings to the Executive Board today is to prevent this from happening again in Mudsock Quilters Guild. I think the "Executive Board" needs to be expanded to all Committee Chairs listed to have a better

representation of the membership.

The next question I have is batting. I have heard through the grapevine that additional batting was being purchased and cut up into workable pieces for future charity projects but "not Community". Please clarify this decision. I also question the decision to have \$2500 budgeted for Community charity. At this point we do not know if we will continue at Community and perhaps this line item should be changed to just "Charity".

Chris responded that we were given very little notice about vacating the storeroom and the bylaws clearly state who is on the executive board.

The meeting was adjourned at 11:30AM.
